A 21st Century Stethoscope

It's the gold standard for Emergency medicine – and we have it at WDMH! A new portable ultrasound machine has arrived, providing immediate care when time is of the essence. The device can help identify diagnoses such as cardiac arrest, internal bleeding, and pregnancy issues. It is also used to support treatment interventions such as draining fluid from the abdomen or inserting chest tubes. It will be used throughout the hospital.

"This device is our lifeline," explains Clinical Manager Katie Robertson. "It will be used daily and will have a significant impact on the care we provide. We are so grateful to the donors who provide these gifts that help us care for all of our loved ones."

The total cost of the ultrasound was \$71,074.

Would you consider adopting us?

The 'Charity Child' – your community as part of your family

When thinking about preparing their will(s), most couples or individuals divide their estate among their immediate family. They want to be sure that they can provide for the needs of their loved ones.

But ask yourself – **who are your loved ones?** Surely your offspring (if you have any), as well as perhaps other immediate or extended family.

But what about causes or charities that have impacted your life? Have you spent hundreds or thousands of hours volunteering? Are you a monthly donor? Have you ever sat on a board of directors? At the very least, have you seen or read about how charities or causes are impacting your community or region?

These are all cues that you may have a 'Charity Child'.

The 'Charity Child' concept is a simple one. You can 'adopt' an additional child through your will – a 'Charity Child', also known as a charity that is close to your heart. This 'child' could be endowed into your estate very simply, by adjusting the percentages that your existing beneficiaries would be receiving after you pass.

- 20% to each of five children → 18% to each child, 10% to charity child
- 33.33% to each of three children → 30% to each child, 10% to charity child
- 50% to each of two children → 40% to each child, 20% to charity child

If you knew your family was going to be cared for, AND you (or they) wouldn't have to pay so much in taxes, how could you skip considering a charitable gift?

Another way to consider it is, if you had a choice to give a portion of your estate to the government in tax, or to a charity like the WDMH Foundation, which one would you prefer? Your decision would have a significant effect on your community – whether you make a charitable gift, or not.

Benefits and features of a 'Charity Child' gift (otherwise known as a bequest or estate gift)

- This way of giving is simple for you to arrange with your lawyer
- You don't need to give now
- Your support for local health care would have a lasting impact in your community
- Special tax incentives are available for gifts of appreciated property (both during life and after passing)
- A 'Charity Child' gift would help to offset unforeseen taxes on your estate (due to a second property, taxes on retirement savings, US assets, high capital gain shares, etc.)
- You are able to specify whether you would prefer to give cash, stock, property, etc.
