WDMH Foundation Bylaws – Approved June 15, 2022

ARTICLE 16 - MEMBERSHIP

- 16.1** Membership in the Corporation shall consist of:
- a) any person whose application for admission as a Member has been approved by a resolution of the Board; and
 - b) directors, upon their election as directors
- 16.2** Subject to subsection 16.1, a person is eligible to become a Member of the Corporation where he or she pays to the Corporation the annual membership due for individuals, an amount to be determined from time to time by resolution of the Board.
- 16.3** At the time of payment of the due described in paragraph 16.2 above, the person must be of the full age of eighteen (18) years.
- 16.4** Any annual membership in the Corporation shall be effective only from April 1 in one year to March 31 in the following year.
- 16.5** A Member shall not be entitled to vote at any meetings of the Corporation unless his/her membership fee was paid in full at least thirty (30) days prior to the date of the meeting and approval of the application for membership has been given by resolution of the Board in accordance with subsection 16.1
- 16.6** Members shall be notified in writing of membership dues at any time payable by them.
- 16.7** Membership is not transferable.
- 16.8** Upon 30 days' notice to a Member, the Board may pass a resolution authorizing the removal of any such Member and thereafter such person shall cease to be a Member.
- 16.9** A Member may resign from the Corporation by delivering a written resignation to the Secretary. In case of resignation, a Member shall remain liable for payment of any assessment or other sum levied or which became payable by him/her to the Corporation prior to acceptance of his/her resignation. A Member is not entitled to a refund of the membership dues in whole or in part.
