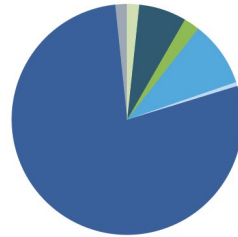


By the Numbers 2023/2024

The primary purpose of the WDMH Foundation is to work with the community to raise funds for Winchester District Memorial Hospital and Dundas Manor Long-Term Care Home.

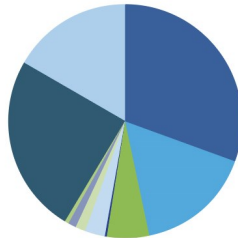
