Ways to Leave Your Legacy

Gifts In Wills (Bequests)

One line in your Will can do so much. Leaving a gift in your Will to the WDMH Foundation creates an incredible legacy and the official charitable income tax receipt your estate will receive may help your beneficiaries receive more. You can leave a specific amount or all or part of the residue of your estate to the WDMH Foundation. Even a gift of 5% to the WDMH Foundation can leave a lasting impact on local health care while decreasing (or eliminating) your final tax bill.

Gifting Registered Funds

Often, parents plan to leave an RRSP, RRIF or TFSA to their children or grandchildren - not knowing that the full balance of their investment will be heavily taxed. But, listing the WDMH Foundation as a beneficiary of an investment not only helps local health care, it's also an effective way to reduce the taxes payable by your estate – your estate will receive an official charitable income tax receipt for the value of your gift. Less taxes to the government means more for your other beneficiaries.

Gifts of Life Insurance

As time goes on, you may decide that your life insurance policy may not be needed the same way as when you created your policy. Perhaps your mortgage is paid off now and your children are grown. You could list the WDMH Foundation as the beneficiary of this policy and know that this gift will leave a lasting impact on local health care. Depending on your policy, you can use a gift of life insurance to receive an official charitable income tax receipt in life or for your estate.

Gift of Shares, Securities or Mutual Funds

When shares, securities and mutual funds are sold/cashed out, you are taxed on their capital gain. But, by gifting/transferring those securities to the WDMH Foundation you can avoid tax on all or some of the capital gain and you will receive an official charitable income tax receipt for the settlement value of your gift.

Gifts of shares can be made during your lifetime, or your estate trustee can gift shares to the WDMH Foundation if it is stated in your Will.


